Payment Plan Options

1. Pay in full by July 1st - 2% discount

- Discount applied after multi-child discount.
- Discounts not available with tuition assistance.
- Discount will be reversed in the event of early withdrawal.

2. Automatic Quarterly Payments

- Payment dates are August 5, November 5, February 5, and May 5.
- Payment dates are the 5th or 20th of each month.

3. Automatic Ten (Aug-May) or Twelve Monthly Payments (Aug-July)

Payment dates are the 5th or 20th of each month.

Please note: Families may pay tuition via their bank account (ACH), credit card, or debit card. If you choose to use a credit card to pay tuition at Legacy, a 2.95% processing fee will be assessed.

Multi-Child Discount

For families with more than one child at Legacy, multi-child discounts of 2% per added student are automatically calculated by FACTS, <u>unless</u> your family qualifies for tuition assistance.

• 2nd child's tuition: \$7,276

• 3rd child's tuition: \$7,131

• 4th child's tuition: \$6,988

• 5th child's tuition: \$6,848

If one child is in Kindergarten, you will receive the discounted tuition on the older child(ren)'s tuition.

FACTS Tuition Management

All tuition agreements for your payment plan and payments for tuition/fees are made through FACTS (https://online.factsmgt.com/SignIn.aspx). FACTS charges either a \$25 or \$55 one-time per year processing fee based on the payment option chosen. All families are required to enroll in FACTS Tuition Management. The enrollment/re-enrollment process is not complete without a payment plan set up through FACTS.

Withdrawal Penalties/Tuition Refunds/Late Enrollment

Withdrawal penalties and tuition refunds will be based upon the following schedule:

- Student withdraws between May 1st and August 31, 2025 \$500 withdrawal penalty
- Student withdraws between September 1st and December 31, 2025 \$1,500 withdrawal penalty, plus payment of prorated tuition(s)*
- Student withdrawals between January 1, 2026 and end of school year payment of balance of tuition
- Tuition is prorated to the last day of the month of withdrawal.
- Any student who enrolls after the first month of school will be charged a book fee of \$350 in addition to the regular tuition.

Past Due Balances/NSF Fee

A student that has a tuition balance more than 60 days past due may not be allowed to attend classes until the account is made current. Any student with a balance still remaining on June 30 will not be allowed to re-enroll until the balance is paid in full or a satisfactory payment arrangement is agreed upon. A non-sufficient funds (NSF) fee of \$30 will be assessed for any payment returned by our bank.

Tuition Assistance

Because tuition assistance is considered a scholarship and the funds are budgeted, the earlier you apply, the more funds are available. We are currency seeking donors and church partners to help with our tuition assistance program. The tuition assistance process requires completion of your federal taxes. You may use the previous year's taxes to apply. Families who apply for tuition assistance may not choose the payment in full plan.

New Families: New families applying for tuition assistance must complete an online application, pay a \$40 tuition assistance application fee, and submit all necessary documentation to FACTS Grant and Aid Assessment via https://online.factsmgt.com/grant-aid/inst/4P1M6/landing-page within 15 days of acceptance to LCA. Failure to do so may result in lower aid awarded.

Current Families: Families applying for tuition assistance must complete the online application, pay a \$40 tuition assistance application fee, and submit all necessary documentation to FACTS Grant and Aid Assessment via https://online.factsmgt.com/grant-aid/inst/4P1M6/landing-page LCA Tuition assistance applications are due by July 1st and are typically awarded by July 15th. Due to budgeting and planning purposes, awards will be decreased by \$250/child for any applications received after May 1st. Late submissions will also result in delayed awards.

Nevada Opportunity Scholarship

The state of Nevada offers the Nevada Opportunity Scholarship, a need-based scholarship, to families on a first-come basis. These scholarships are not provided by LCA. To apply, you must apply directly through the organizations. Once awarded a scholarship, families share this information with LCA.

Even if you intend to apply for a tuition assistance &/or have been awarded assistance, LCA still needs a completed tuition contract signed by a guardian on file, as ultimately the guardian(s) are the guarantor(s) that the tuition will be paid in a timely manner. Tuition is necessary for LCA to provide the materials, structures, & professionals needed to educate your children.
